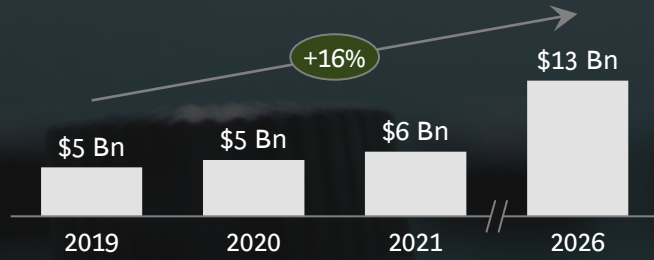

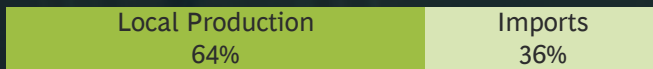

Value Proposition

Egypt's local pharmaceutical market is projected to grow rapidly at a **16% annual rate through 2026...**

Egypt can continue to expand its pharma exports, by exporting to:



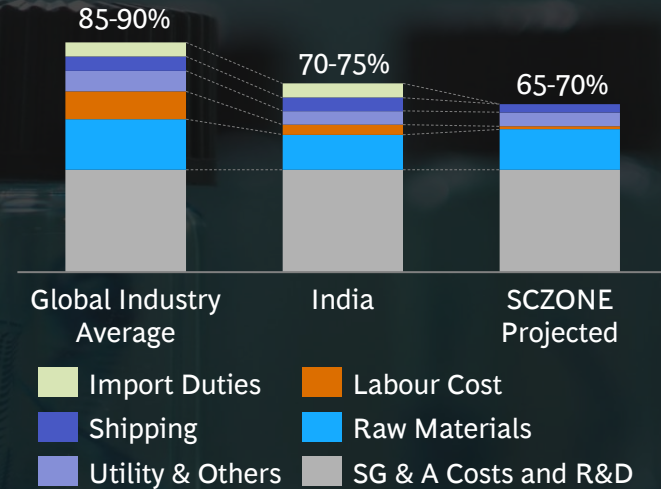

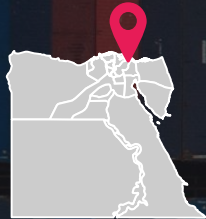

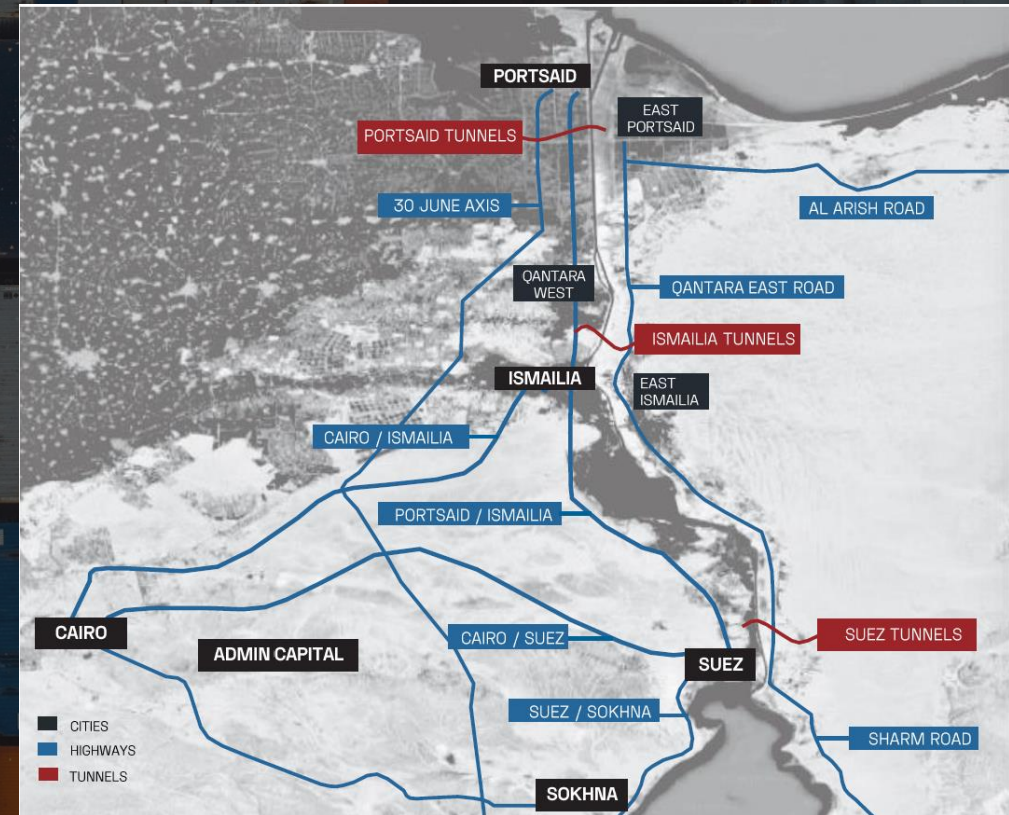
